I hereby release Bear Valley Cross Country, Inc. (BVCC, Inc.), Bear Valley Adventure Company, Mountain Bikes, Kayak Bear and its employees, agents, and representatives of any kind from any liability for damages to person or property resulting from the use of equipment rented as listed herein.

I have received in good condition all equipment listed on this receipt and agree to return same in good condition except for wear and tear incident to the normal usage of such equipment. I further agree to pay for any loss or damage to same at replacement or repair cost as appraised by authorized agent of BVCC, Inc. I agree that in the event the equipment becomes unsafe or in a state of disrepair I will immediately discontinue use and promptly return it to BVCC, Inc. I understand that any deposit I may pay represents only a fraction of the value of said equipment. I understand that I will be charged a late fee for any overdue equipment (\$10 per boat for each 1/2 hour late). \_\_\_\_\_ (initial)

I acknowledge that BVCC, Inc. provides personal flotation devices for my protection, and I agree to wear the personal flotation device (life jacket) while using the equipment. I understand that flatwater sea kayaking and canoeing are inherently dangerous activities that can result in serious injury or death and agree that I am assuming all such risks caused by my participation therein. I agree that BVCC, Inc. has no duty to supervise my conduct or that of others, or to guarantee any water, wind or other environmental conditions. I have read, understand and agree to follow the BVCC Flatwater Sea Kayak/Canoe Rules and Regulations.

I understand and agree that I am solely responsible for any damage which may occur to my vehicle, or other vehicles or property, as a result of transporting flatwater sea kayak/canoe rentals.
